| 1. | How long is an unused EudraCT number valid for? | A EudraCT number is a unique identifier of the trial and once issued, it never expires. It identifies a specific trial. |
| 2. | How many languages are supported in EudraCT? | Although EudraCT supports entry of clinical trial data in any EU language, it is recommended for sponsor to provide the information, such as for the title of the trial, also in English. |

| 4. | Is a retrospective trial registration possible in EudraCT? | For any enquiry on the retrospective registration of a clinical trial, sponsor has to liaise directly with the National Competent Authority of the Member State where the trial was conducted. | 5. | Where can I obtain the XML schema to prepare a clinical trial application? | The EudraCT Clinical Trial application form schema (.xsd) is available in the Technical Information section of the supporting documentation pages of the EudraCT website: https://eudract.ema.europa.eu/protocol.html |
| 6. | Are trials using medical devices required to be included in the EudraCT database? | Directive 2001/20/EC does not apply to medical devices, active implantable medical devices, and in vitro diagnostic medical devices as defined in Community legislation. You are advised to follow procedures on devices in place in the country where the clinical trial is conducted/will be conducted. Contact the National Competent Authority of the country(ies) concerned for further details: https://eudract.ema.europa.eu/nca_contacts.html |
| 7. | How do I register a trial in EudraCT? | <p>Directive 2001/20/EC establishes specific provisions regarding the conduct of interventional clinical trials, including multi-centre trials on human subjects involving medicinal products.</p> <p>Sponsor may not start a clinical trial until the Ethics Committee has issued a favourable opinion and the Competent Authority of the Member State concerned has not informed sponsor of any grounds for non-acceptance.</p> |

| | | <p>Before commencing a clinical trial, sponsor shall be required to submit a valid request for authorisation to the Competent Authority of the Member State in which the sponsor plans to conduct the study. The response from the Competent Authority, whether the request for authorisation is positive or negative, could take up to 60 days.</p> <p>Before submitting an application to the National Competent Authority, the applicant should obtain a unique EudraCT number from the EudraCT Community Clinical Trial System by the procedure described in the Help file:</p> <p>https://eudract.ema.europa.eu/help/Default.htm#eudract/create_eudract_no.htm</p> <p>This number identifies the protocol for a trial, whether conducted at a single site or at multiple sites in one or more Member States.</p> <p>To obtain the EudraCT number automatically from the database the applicant will need to provide a few items of information.</p> <p>The applicant should submit a signed cover letter with the application. Its subject line should contain the EudraCT number and the invariable sponsor protocol number (if available) with the title of the trial.</p> <p>Please note that the concept of sponsor and Legal Representative of the sponsor are both in the CT1 guidance attached and in the Directive as well.</p> <p>From a practical point of view you need to follow the instructions below:</p> |

| 8. | Why a clinical trial is not visible in the EU CTR? | <p>This could be due to the following:</p> <ul style="list-style-type: none"> • sponsor has not submitted the Clinical Trial Application form to the National Competent Authorities; • The application form was submitted by sponsor but not uploaded into the system by the National Competent Authority probably due to on-going evaluation of the application form. |

| 9. | Can I save an invalid or incomplete Clinical Trial Application? | Yes but only locally and not in the EudraCT system. It is recommended for sponsor to save locally the incomplete Clinical Trial Application to amend it if needed. |
| 10. | Can I save an invalid or incomplete third country XML file on EudraCT? How to make amendments in a completed third country file? | Yes it can be saved in EudraCT. To amend a third country XML file sponsor can download an existing third country XML file on the EudraCT public website, edit and upload again the revised XML file to EudraCT. It is strongly recommended to save XML file/amended XML file also locally. |
| 11. | Can I prepare a Clinical Trial Application submission with a clinical trial application that does not meet all of the business rules as identified in the validation error report? | Sponsor has to resolve errors in the business validation rules before submitting the CTA to the NCA. The NCA might not be able to accept the application form if any outstanding issues have not been resolved in advance. |
| 12. | How to register a new substance in EudraCT? | <p>In the event that the new substance is not available through the search functionality in EudraCT, it is advised to register the new substance in the XEVMPD following the link provided on the EudraCT application. The EMA can offer punctually to sponsor not yet registered with EudraVigilance to register the new substance on their behalf. For non-interventional clinical trials it is advised to refer to ENCEPP database https://www.encepp.eu/. | 16. | Is it necessary to enter information on NIMP in the clinical trial application form? | For interventional clinical trial on medicinal product(s) it is required to fill in the Clinical Trial Application form but it is not required to include information on NIMPs in the application. |
| 17. | How to populate the legal representative question in EudraCT? | In order for the legal representative section to be activated in the system sponsor has to provide the country in section B.1.3.4. If the main sponsor of a clinical trial with a medicinal product is not based in the European Economic Area (EEA), for example, an American or Japanese company, it is a statutory requirement to appoint a legal representative based in the EEA for the purposes of the trial. Result-related information for non-paediatric trials included in an agreed PIP should be posted within 12 months of the end of the trial. | 25. | What are the different statuses of trial results in EudraCT? | The trial results in EudraCT have the following three statuses: draft (when results are being prepared), posted (when the results have passed the validation stage) and finalised (when the results are final and are published if the trial record meets the publication rules). When results are in draft, the data can be updated at any time. When results are in finalized status, they can be updated with the creation of a new version. The new version as well as the old version will be published in the EU CTR to keep track of the changes and for transparency reason. |
| 26. | Are results required in EudraCT for phase 1 studies? Are they made publicly available in the EU CTR? | All the results for phase I-IV clinical trials are required to be posted to EudraCT. However, Phase 1 trials, which are conducted solely in adults and which are not part of an agreed PIP are not made public. Maximum file size: 50MB per file.</p> |
| 30. | When does a full data set need to be entered and when does a CSR synopsis fulfil the results requirements? | <p>For studies that ended on or after the date of the finalisation of the programming (21 July 2014), a full data set is mandatory.</p> |
| 31. | Can an extension be granted for posting of paediatric trials results? | <p>Commission Guideline 2009/ C 28/01 in Section 2.2.2 states that <i>result-related information for paediatric trials should be submitted to the EMEA, for entry into EudraCT, no more than six months after the trial has ended, whether the trial has been completed or prematurely terminated, whichever occurs first. However, notwithstanding the above, if (a) the clinical trial does not fall within the scope of Article 46(1) of the Paediatric Regulation, and (b) it is for objective scientific reasons not possible to submit the result-related information within six months, which has been demonstrated by the submitting party, result-related information for paediatric</i></p> |

In case no subjects were recruited it is not appropriate to complete the full dataset for results. However there is currently no functionality for sponsors to inform that recruitment never started. If this is an old trial and there is an end of trial/withdrawal reported by sponsor, a comment should be entered by the NCA that no subjects were recruited. Sponsor should liaise with the NCAs of the Member State(s) concerned by this application.</p> |
| 33. | How to update sponsor details in the event of changing the sponsor of a clinical trial? | <p>Change in sponsorship is not within the remit of the EMA. | 34. | If we have multiple preferred terms in the AE section, how do we ensure it is not considered duplication but a single AE term referred to two different SOC's? | The release 10.4.0.0 caters for this scenario. In this case the system will consider the term a new AE term belonging to a different SOC and there won't be any error when validating the results. |
| 35. | For one of my study which was earlier released on EudraCT, a new version was created for a single change in the value. However, the single value needs no correction hence we would like to discard the version 2. | The EMA does not allow removal of data provided by the sponsor in EudraCT. All the versions of results remain in the system for transparency reason. If there is a change in a value in V1, this will be clearly stated in the justification sponsors have to give when updating the version of the results. |
| 36. | How to create EudraCT numbers in the test environment? | After registering as a result user in the training environment the system will assign the result user a 'dummy EudraCT number'. <u>A real EudraCT number cannot be used</u> . | 37. | Late results summary submission: Is there any process for notifying of a result summary that will not meet the deadline? What are the implications for not posting results on the EU Register or posting late? | There is no requirement for the sponsor of a clinical trial to notify the Agency of the late submission of clinical trial results. It is legal responsibility of the relevant National Competent Authorities to liaise with the sponsors for compliance with the Commission Guideline 2012/C 302/03. (Refer to Question 31 regarding a potential extension.) |

| 42. | Is all protocol data published in the EU CTR? | Protocol data for all types of investigational studies/trials needs to be entered in the EudraCT database, however phase I trials data is not to be made public on EU CTR, unless it is part of an agreed PIP. Although the information is not made public, it is a legal requirement for sponsor to provide the results of the trial.
